

**LICENSE AGREEMENT AND LIMITED WARRANTY**

**IMPORTANT - PLEASE READ THIS AGREEMENT CAREFULLY**

The short version: This is a non-exclusive, non-transferable license for you, the “end user”, to use our art packs for the purpose of creating finished maps or artwork intended for both private and commercial purposes. You do not need to plaster our logo all over any finished artwork you make with this set, but credits are always appreciated if you have the ability to do so. You may not share this pack with anyone else, either “as-is” or altered. If you need help or have questions, ask us. However, you may not use it to create another art pack, “tube”, or other form of resource for public release (commercial or non-commercial).

This End-User License Agreement (“EULA”) is a legal agreement between you and Scrying Eye Games (“SEG” or “we”) for the digital art packs stated above, which includes all code and graphic assets included therein and any future upgrades or updates thereof (collectively referred to herein as “Art Pack”). The Images and files in the art pack are copyrighted and protected under the various laws of the United States, International treaties and other applicable laws. The Images and files shall remain the sole and exclusive property of Scrying Eye Games and/or its licensors. Use of the Images is licensed, not sold, pursuant to the terms of this License Agreement. Use of the Images without agreeing to this License Agreement, or a breach of these License Agreement terms, is copyright infringement.

**1. Technical Support**

**2. License**

Subject to the other requirements of this EULA (including but not limited to the Credit requirements of Section 8, as applicable), you are granted a non-exclusive and non-transferable license to use the art pack in the following manner:

- (a) you may load the Art Pack into and use it on a single computer which is in your custody and control for your own for either private and domestic use;
- (b) you may transfer the Art Pack from one computer to another provided it is used on only one computer at any one time and any computer on which it is used is under your custody and control at the time of use;
- (c) you may make as many copies of the Art Pack in machine readable form for personal backup purposes only, provided that all copyright and any other proprietary legends or other notices on the original are reproduced in full and they are retained entirely under your control;
- (d) you may use the Art Pack to create items for personal use or resale, including book covers, maps, calendars, interior artwork, adventures, modules, and consumer merchandise, provided such use is not intended to allow the re-distribution or re-use of the images themselves.
- (e) you may use images from the art pack as décor or gaming props in office areas, lobbies, public areas, restaurants, or retail stores. The images may be used as design elements in video, film, or television broadcasts.
- (f) you may use the images in connection with your business or entity (i.e., letterhead and/or identity documents, provided the restrictions in paragraph 3(b) are followed.
- (g) you may modify or alter images from the art pack as necessary for your use, provided that if such modification or alteration constitutes a derivative work, the rights to all such derivative works shall be retained with Scrying Eye Games, and that you shall only use such derivative work in accordance with this agreement.
- (h) you acknowledge that this is a non-exclusive, non-transferable license, and you may not transfer the Art Pack or its license in any fashion to any other person or entity without the express written permission of Scrying Eye Games.

(i) your rights of use under this EULA are strictly conditional upon your observance of the terms and conditions contained in this Agreement.

### **3. Restrictions**

Notwithstanding anything to the contrary contained herein, you are not permitted under any circumstances:

- (a) to load the Art Pack on to a network server for the purposes of distribution to one or more other computer(s) on that network or to effect such distribution.
- (b) to sublicense, distribute, or assign the images or rights to the images to another party except as outlined in paragraph 2(h).
- (c) to use any portion of the art pack as part of a trademark, service mark, logo, or any other design in which you establish your own rights. Scrying Eye Games or its licensors retain full rights to the images in the art pack.
- (d) to use the art pack or the images within the art pack to create a database or as material for a mapping program or application.
- (e) to use the art pack in a product or service whereby the images from the art pack can be used apart from the product or service.
- (f) to use the art pack in any way that could be considered defamatory, pornographic, libelous, immoral, obscene or fraudulent, or illegal, either by making physical changes to it, in the juxtaposition to accompanying text or images, or otherwise.

### **4. Termination**

Without prejudice to any other rights, any breach terminates this EULA so Scrying Eye Games may terminate this EULA immediately and without notice if you fail to comply with the terms and conditions of this EULA. In the event of termination, you must destroy all copies of the Art Pack and all of its component parts including any Art Pack assets stored on the hard disk of any computer. All provisions of this EULA relating to disclaimers of warranties, limitations of liability, remedies, or damages, and Scrying Eye Games proprietary rights shall survive termination.

### **5. Ownership**

You only own the media (if any) on which the Art Pack is recorded. The Scrying Eye Games and/or its licensors shall at all times retain ownership of the Art Pack as recorded on the media and all subsequent copies regardless of form.

### **6. Warranty Disclaimer and Exclusions**

6.1 THIS ART PACK IS PROVIDED "AS IS" AND WITHOUT WARRANTY OF ANY KIND OR NATURE. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, SCRYING EYE GAMES AND ITS LICENSORS DISCLAIM ALL OTHER REPRESENTATIONS, WARRANTIES, CONDITIONS OR OTHER TERMS, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO IMPLIED WARRANTIES AND/OR CONDITIONS OF TITLE, NON-INFRINGEMENT, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WITH REGARD TO THE ART PACK AND EACH AND EVERY PART THEREOF. WITHOUT PREJUDICE TO THE GENERALITY OF THE FOREGOING, SCRYING EYE GAMES DOES NOT WARRANT THAT THE ART PACK IS ERROR-FREE OR WILL OPERATE WITHOUT INTERRUPTION, NOR THAT IT WILL REPAIR ANY ERRORS IN THE ART PACK.

- (A) IN NO EVENT SHALL SCRYING EYE GAMES OR ITS LICENSORS, LICENSEES, OR OTHER SCRYING EYE GAMES PARTNER OR AGENT BE LIABLE FOR ANY DAMAGES WHATSOEVER (INCLUDING, BUT NOT LIMITED TO, DIRECT, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES FOR PERSONAL INJURY, LOSS OF PROFITS, BUSINESS INTERRUPTION, LOSS OF INFORMATION, OR ANY PECUNIARY LOSS) ARISING OUT OF THE USE OF OR INABILITY TO USE THIS ART PACK, EVEN IF SCRYING EYE GAMES HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
  - (B) IN ANY CASE, THE MAXIMUM AGGREGATE LIABILITY OF SCRYING EYE GAMES AND ITS LICENSORS UNDER OR IN RELATION TO THIS EULA OR THE USE OR ATTEMPTED USE OF THIS ART PACK SHALL BE LIMITED TO US \$10.00.

### **7. Required Credit**

7.1 There is no credit requirement by the End User to the Scrying Eye Games for any finished product, provided the above

requirements in Section 3 are maintained. This includes either personal or commercial use, for use in a finished product for publication on the web, printed matter, VTT, or other use.

7.2 If the End User wishes, the Scrying Eye Games appreciates credit for the Art Pack, and grants the End User permission to use the Scrying Eye Games logo as part of the finished product. The Scrying Eye Games further thanks and grants permission by the End User to credit the Scrying Eye Games in either the credits page or as a web link back to the Scrying Eye Games. Such logo will be either included in the Art Pack, or shall be made available upon request.

## **8. Miscellaneous**

8.1 This EULA and any claim or dispute of whatever nature arising out of or relating to this EULA shall be governed by, and construed in accordance with the laws of the State of Florida, USA, without regard to their choice of law provisions. Any dispute arising out of this EULA or the use or other disposition of the Art Pack will be brought and resolved in the state or federal courts in Florida.

8.2 The United Nations Convention on Contracts for the International Sale of Goods shall not apply to this EULA.

8.3 If you acquired this Art Pack in the United States of America, you will not export it except as authorized and permitted by the laws and regulations of that country.

8.4 This EULA constitutes the entire agreement between Scrying Eye Games and you with respect to the license and use of the Art Pack and supersedes all prior or contemporaneous understandings. Without limiting the foregoing, this EULA supersedes any and all prior agreements in effect regarding the use of this Art Pack (or any earlier version thereof), express or implied, as if you had entered into this EULA at the time you obtained a copy of the Art Pack or earlier version thereof. No amendment or modification of this EULA will be binding unless made in writing and signed by a duly authorized representative of Scrying Eye Games. Scrying Eye Games may freely assign any or all of its rights and obligations under this EULA.

8.5 In the event this EULA is not deemed to cover a particular use or disposition of the Art Pack, your rights are limited to those available under the fair use provision of the US Copyright Act.
